The Lessee shall not have the right to relocate the animal without the express written permission, except as may be customary for uses as indicated above.

TRANSPORT: Transport costs from property of origin to Lessee address and return will be born by Lessee, Lessor,

Additional:

RESPONSIBILITY: the Lessee is primarily responsible for ensuring that the animal has appropriate housing, food, water, veterinary treatment and health care. Unless otherwise specified, all costs incurred during term of lease are to be the responsibility of the Lessee.

The Lessee will be responsible for collecting, recording and forwarding height measurements, photographs and other such information required for AMGR registration purposes for this animal and any costs involved with such.

Unless otherwise specified, the Lessee assumes full responsibility for injury, illness or loss of the animal and all costs associated from such. In the event of injury, illness or death of the animal, the Lessee MUST notify the Lessor immediately. Veterinary treatment must be obtained and where possible, every effort must be made to return the animal to a fit and healthy state. The Lessor must be kept fully informed of all treatment/s and progress of the animal at all times.

In the event of death /loss of the animal, the Lessee shall be liable to pay \$ or alternative

, payable to the Lessor who will hold no further claims against the Lessee.

The Lessee, through the term of this lease, will be solely responsible for any accident, injury or illness to any person or animal who comes in contact with the animal and will be solely responsible for loss, damage, claim, cost and expense (including legal expense) arising out of or in connection with the use or actions for the leased animal. The Lessee agrees not to encumber said animal with any lien, charge, or related claim and to hold the Lessor harmless there from and the Lessee shall have no right, title, or loan to any other party except as stated here.
